## **PROJECT SCHEDULE**

- Notice to Proceed slated for 4/17/2023
  - First few weeks of work will include surveying and potholing
- Construction expected to proceed between April and November 2023 with close out items being completed in December 2023.

### **PROJECT SCOPE & IMPACTS**

- Contractor will be installing an 8" water line along the South side of Trevarno Road and an 8" sewer line along the North side of Trevarno Road. Including demolition and replacement of fire hydrants, laterals, cleanouts and water meters.
- Potential minor root trimming may be required in some areas to install utilities
  - o Any disturbed landscaping or irrigation will be replaced in kind prior to project completion
- Contractor will be saw cutting existing roadway, median and curb in order to install utilities
  - o Any disturbed roadway, median and curb will be replaced in kind prior to project completion

- Construction & Noise Hours: 7:00am to 5:00pm
- Contractor will be occupying portions of the median during construction
- Potential lane closures will occur with construction equipment and traffic control utilizing flagmen
  - Residents will be informed ahead of time of impacts
- Upon completion of new sewer and water systems
  - Each home owner will be required to have their private contractor visit the site and tie-in to the installed cleanouts and water meters
  - Each home owner will be required to abandon the sewer 6" main, laterals and any manholes within their property boundaries (either full removal or slurry and capping of existing line)
    - City has copies of individual lot layouts for reference
- Homeowners must complete the abandonments in a timely manner so Contractor can abandon the remaining water and sewer laterals along Trevarno Road within the contract completion date
- Upon completion of the project, contractor will slurry and re-stripe entire roadway
