8.01 Hearing to consider a request to authorize a telecommunications facility <u>Staff</u> consisting of three antenna arrays (three antennas each array; nine antennas <u>Report</u> total) on an approximately 70-foot tall pole to be camouflaged as a pine tree. The faux pine tree and ground-mounted telecommunications equipment would be based within an approximately 12- by 30-foot enclosure in Independence Park north of the park's parking lot off Holmes Street.
