ADDITIONAL INFORMATION AND ACKNOWLEDGEMENTS

Livermore Municipal Code (LMC) Section 5.50.100 prohibits the sale, offer for sale, exchange, or offer to exchange any flavored tobacco product, including electronic smoking devices and electronic smoking device fluid.

The following definitions in LMC Section 5.50.020 are applicable to all tobacco retailers:

"Characterizing flavor" means a taste or aroma, other than the taste or aroma of tobacco, imparted either prior to or during consumption of a tobacco product or any byproduct produced by a tobacco product, including, but not limited to, tastes or aromas relating to menthol, mint, wintergreen, fruit, chocolate, vanilla, honey, candy, cocoa, dessert, alcoholic beverage, herb, or spice.

"Electronic smoking device" means any device or delivery system that can be used to deliver nicotine in aerosolized or vaporized form to a person, as well as any component, part, or accessory for the device that is used during its operation. "Electronic smoking device" includes electronic cigarettes as defined in section 30121 of the California Revenue and Taxation Code, and any other device manufactured, distributed, marketed, or sold as an electronic cigar, an electronic cigarillo, an electronic pipe, an electronic hookah, or any other product name or descriptor, that can be used to deliver nicotine in aerosolized or vaporized form to a person. "Electronic smoking device" does not include any product that has been approved by the United States Food and Drug Administration for sale as a tobacco cessation product or for other therapeutic purposes where that product is marketed and sold solely for such approved use.

"Electronic smoking device fluid" means any liquid or substance that can be used by an electronic smoking device.

"Flavored tobacco product" means any tobacco product that imparts a characterizing flavor.

"Tobacco product" means any product containing, made from, or derived from tobacco or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means, including, but not limited to cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, snuff; any electronic smoking device; any electronic smoking device fluid; and, any component, part, or accessory of a tobacco product, whether or not sold separately.

In addition, LMC Chapter 5.50 prohibits the issuance of a new tobacco retailer license, and no existing license may be renewed, within 1,000 feet of a youth populated area except as provided in Section 5.50.050.D.

"Youth populated area" means a parcel that is occupied by a private or public kindergarten, elementary, middle, junior high, or high school, public library, public playground, youth center, public recreation facility, or commercial childcare or preschool facility. Refer to LMC 5.50.020.O for the complete definition.

In LMC section 5.50.050.D, tobacco retailers in existence at the time the tobacco retailer's ordinance was effective (August 8, 2019) and located within 1,000 feet of a youth populated area are considered legal nonconforming general retail land uses subject to the provisions of Chapter 9.16 of the Livermore Development Code, Nonconforming Provisions. Floor area dedicated to the sale of tobacco products is limited to what was in existence at the time the ordinance was effective.
