

LIVERMORE MUNICIPAL WATER LAUNDRY-TO-LANDSCAPE REBATE APPLICATION FORM

Why send your property's water down the drain when you could reuse it to irrigate the plants and trees in your yard instead? Many Californians are taking advantage of this simple idea and are installing laundry-to-landscape greywater systems to keep their gardens green. During water shortages or droughts, greywater systems can be a reliable supply of water for your plants. Livermore Municipal Water offers rebates up to \$100 for customers to install a laundry-to-landscape greywater system.

REBATE TERMS & CONDITIONS

- This rebate is only available for residential properties with one or two units that are located within Livermore Municipal Water's service area. Properties within Cal Water's service area are not eligible for this rebate.
- This rebate can only be used for laundry-to-landscape greywater systems. Greywater systems that include water from sinks, showers, or bathtubs or that alter the building's plumbing system are excluded.
- This rebate can be used towards reimbursing the cost of any supplies listed on the "<u>Laundry-to-Landscape</u>: <u>Greywater System Example Parts List</u>" sheet. This rebate cannot be used towards sales tax or the cost of any deliveries, installation, labor, personal items, equipment rentals, or tools. The application must be received within 90 days of purchasing laundry-to-landscape supplies. Each residential unit can receive a rebate up to \$50. Limit one rebate per residential unit for the life of the program.
- Applicant is responsible for ensuring that their laundry-to-landscape greywater system complies with California Plumbing Code 2019 CPC Chapter 15 and City of Livermore Municipal Code (LMC) 13.25.170.
