Livermore Wins 2021 All-America City Award!

ommunity-driven initiatives are what led to the City of Livermore winning the prestigious 2021 All-America City Award during the National Civic League ceremony on June 9th. Since 1949, the National Civic League has celebrated the best in American civic innovation by awarding ten communities nationwide.

The theme of this year's competition was "Building Equitable and Resilient Communities." Following a rigorous application process, 20 finalist cities from across the country competed through 10-minute live virtual presentations followed by question and answer sessions with the judges.



The only city in California to receive the award this year, Livermore impressed the judges by highlighting the community's collaborative approaches for addressing: youth mental health; anti-vaping policy and education; equity, inclusion, and social justice; and, affordable housing and homelessness.

Presenting from Livermore were students, community members, and staff from the City of Livermore, Livermore Valley Joint Unified School District (LVJUSD), Las Positas College, and Livermore Area Recreation and Park District (LARPD). The All-America City judges were especially impressed by the passionate commitment of Livermore youth, the partnerships amongst the community agencies, and the comprehensive efforts to offer housing and wrap-around services to local community members experiencing homelessness.

Livermore's presentation illustrated the shared vision, civic engagement, inclusiveness, collaboration, and innovation within the city that has resulted in positive changes and growth for the citizens of Livermore. *Watch Livermore's presentation:* https://youtu.be/1aDmprX8vM4

Be Prepared

With the rainy season upon us, please consider the below tips to help with safety on and off the road. Also, check out the City's storm preparedness webpage at www.cityoflivermore.net/storm to see where sandbags are available, who to contact for storm-related issues such as downed trees or power lines, and to find out if you live in a floodplain.

PREPARE



If you have a life-threatening emergency,

call 9-1-1.

Do not approach, drive over, or touch downed power lines. Assume they are energized.

If your property is in danger of flooding, turn off your power and contact PG&E at 1-800-743-5002.

Tune in to local weather channels and emergency sources: KCBS 740AM, NOAA Weather Radio (frequencies 162.425, 162.400).

To report flooding, contact the Water Resources Division at (925) 960-8100.

Do not drive into water that is high enough to reach the undercarriage of your vehicle.

STAY SAFE



Determine if your property is located in a flood zone by contacting the Engineering Division at (925) 960-4500.

Purchase flood insurance. For more information, call 1-888-FLOOD29

(1-888-356-6329).

Protect your property and keep emergency supplies in your home, car, and place of business.

Sign up to receive emergency alerts from PG&E (pge.com) and Alameda County's emergency notification system, AC Alert (acalert.org).

Clean out your gutters. Keep drainage channels and pipes free of obstructions and debris.

Acquire and use sandbags preventatively.

The Livermore Public Library completed another successful annual Summer Reading Program. The theme of the 2021 program was "Reading Colors Your World." The Library's diverse events and enthusiastic participation of readers of all ages underscored the program's theme. Four incentive-based reading programs targeted pre-readers, children who read independently, teens, and adults.


Budget-in-Brief

The Fiscal Years 2021-23 Financial Plan (The Plan)

is a two-year financial blueprint for fiscal years 2021-2022 & 2022-2023 reflecting the City Council's goals and priorities for the community. The Plan is a shortterm economic outlook emerging from the COVID-19 pandemic event, providing an overview of citywide revenue and expenditure projections. The good news is that the City remains relatively financially healthy. The Plan maintains the current operational service levels to support Livermore's high quality of life. Below is the fiscal year 2021-22 general fund resources and expenditures. 
FY 2021-22 Where the Money Comes From?

Goals and Priorities

Every two years, a Council goals and Priorities workshop is held to identify, discuss, and prioritize issues that will be addressed over a two-year period. Listed below is the approved Fiscal Years 2021-23 City Council Goals and Priorities.



Asset Management & Stormwater
Establish and maintain comprehensive Asset
Management and Stormwater Management

Downtown

Enhance the City's vibrancy by completing critical projects downtown, ensuring the right balance of local amenities to support quality of life.



General Plan Update

Comprehensively update the Livermore General Plan, including Housing Element and Programmatic EIR, to address changes in regional and state policy, market trends, and community preferences, to plan for growth and conservation for the next 25 years, and support and enhance Livermore quality of life.



Homelessness and Affordable Housing

Establish a homelessness strategy, engaging local partners to develop a coordinated response, and expand diversity of affordable housing opportunities.



Modernization, Training, and Workplace Enhancements

Develop a systematic approach to modernizing the City's aging business systems, reviewing processes for alignment with industry best practices, and providing our workforce with the tools and training necessary to effectively deliver services to the community.

Capital Improvement Plan

Livermore's Capital Improvement Plan (CIP) is a 20-year plan that serves as a blueprint for future public projects. Most of the CIP is funded from non-general fund sources such as outside agency contributions, grants, user fees, and local development fees. The 2021-23 CIP includes a total budget of \$152 million to cover 83 projects over a two-year period.



Downtown Revitalization:

Major construction projects are well underway Downtown. These projects enhance the Downtown experience and most are part of the Downtown Core Plan that was adopted by the City Council in January 2018. Currently, the I Street Garage is under construction at Railroad and Livermore Avenues. This parking garage will connect to the existing garage on all three levels and offer 274 new parking spaces along with a smartphone parking app to track space availability. Construction is scheduled to be completed by the Summer of 2022.

Livermorium Plaza is also currently under construction at the corner of First Street and Livermore Avenue. This plaza will feature a 5-foot diameter granite water ball fountain, which represents the nucleus of the Livermorium atom. In the ground surrounding the ball will be 116 "electrons" represented by a combination of tree wells, accent lights, and granite and decorative concrete discs. Both the water ball and granite disks will be engraved with facts about Livermorium and other elements, creating a learning opportunity for visitors. Construction is scheduled to be completed by late Spring 2022.

Other construction activities include streetscape improvements on First Street from L Street to M Street, and enhancements to street lighting and sidewalk accessibility. Construction will begin on the Livermore Village Garage (previously referred to as the L Street Garage) at the end of 2022. This garage will contain 460 spaces and be located at L Street and Veterans Way.

Transportation - Vasco Road Widening Project:

The Vasco Road widening project will add a second northbound lane to Vasco Road north of Garaventa Ranch Road through the Dalton Avenue intersection. This project will improve traffic flow and increase the safety of cyclists through the addition of a separated bikeway. Construction is tentatively planned to start in Fiscal Year 2022-23. This project is funded by Traffic Impact Fees.





Did you know that your tax dollars are used to install and maintain all the traffic signals in Livermore? There are more than 100 signalized intersections throughout the City, each which costs around \$650,000 to build and maintain. Mandatory Watering Restrictions are Now in Effect Citywide

California is experiencing a severe drought. With water supplies at historic lows, the Livermore City Council declared a Water Shortage Emergency on September 27th and activated mandatory outdoor watering restrictions.

Our goal is reducing our water use by 15% citywide and it is essential that we all save as much water as possible. Here is what you need to know:


- ♦ All landscaping throughout Livermore may now only be watered a maximum of three times per week.
- ♦ Odd numbered street addresses may only water on Mondays, Wednesdays, and Fridays.
- ♦ Even numbered street addresses may only water on Tuesdays, Thursdays, and Saturdays.
- ♦ No watering allowed on Sundays.
- ♦ Hand watering & drip irrigation allowed at any time on property's approved watering days. No sprinkler irrigation between 9:00 a.m. and 6:00 p.m.

There are two water service providers in Livermore – the City of Livermore (Livermore Municipal Water) and California Water Service – Livermore District (Cal Water). These watering restrictions apply to all properties within city limits, regardless of their water service provider.

The City of Livermore is updating its General Plan, the 20-year plan that guides City decisions about housing, shopping, transportation, services, parks, jobs, and The General Plan Update more. will take approximately two and a half years. The Plan allows the community to re-evaluate policies and develop new ones that address shifts in community priorities, technologies, and other real estate market trends. The City and its consultant team will be hosting a wide variety of community events through various platforms and formats to hear from members of the community and gather opinions and insights.

The City Council has appointed a General Plan Advisory Committee to represent and further the interests of the community and long-term vision of the City. The Committee will provide input and feedback to City staff and serve as liaisons to the community throughout the General Plan Update process.
